Duty free importation provided: The baggage is "bona fide", i.e., it should consist of goods for personal use and for the use of the family members only. It should NOT include: Goods in commercial quantities. Goods (unaccompanied baggage), which arrive after 90 days of your arrival. Make a written declaration. Fill all sections of the form, with passport N°, last date of departure from Sri Lanka, and date of arrival etc. All currencies, jewelry, etc., must be declared with details. Ensure your passport is endorsed by Customs at the time of arrival. Duty free allowances: Period less than 90 days unaccompanied baggage up to US\$ 125.
