SHIPMENT DECLARATION

Used household goods and personal effects

REQUIRED DOCUMENTATION

- Original Bill of Lading / Airway Bill. (Express release B/L accepted for non-diplomatic shipments)
- Legible copies of owner's passport and packing list. Original or copy of the insurance policy, if shipment is insured. Waybill with shipper's contact address / numbers
- Additional documentation required for customs clearance would be obtained from owner locally in Jordan
- All original shipping documents must be received by us at least 10 days before arrival of shipment
- Jordanian income tax number of Jordanian temporary income tax number for foreigners

IMPORT REGULATIONS / CUSTOMS CLEARANCE

- Personal effects are subject to open inspection by Customs authorities
- Normal customs clearance takes 4-5 working days for sea freight and airfreight (up to 7 working days during peak season i.e. May to Aug)
- Customs duty is at present 52% of the value estimated by customs on all household goods and used motor vehicles
- Vehicles are allowed to import in Jordan, unless older than 5 years or diesel will not be allowed to import even they are under diplomatic status
- Books, literature, audio/video cassettes, records, CDs, etc. are subject to screening by Customs
- Prohibited articles detained by customs may be confiscated and destroyed without consignee's consent.
- Re-export of the items is not possible and is not the responsibility of GAC

PROHIBITED ARTICLES

- Any type of pornographic material including simple nudity
- Alcoholic beverages including fine wines
- Medicines and medical drugs (only prescription drugs in limited quantities)
- Wireless transmitters / receivers, satellite antennas
- Firearms, ammunition, explosives and any type of weapons including swords and daggers even if they are only ornamental in nature
- Any narcotic / psychotropic substances including seemingly innocent dried poppy flower arrangement
- Political and religious literature / articles deemed offensive to the Jordanian government, Islamic and Christian faith
